6. <u>President's Report</u>

President Wendy Fennah tabled the following Report.

It is my privilege to present the President's report of the Association of Queensland Nursing & Midwifery Leaders (AQNML).

Firstly, I would like to thank the members of the Executive Committee for their assistance, work and support of the past year. They are: Vice President Melinda Daniels, Secretary/Treasurer Carolyn Bourke and Committee Members – Anita Bolton, Pauline Calleja, Jennifer Craig, Nicki Dennis, Andrea Hawkins (Nagle), Doug Kynaston, Lisa Milne, Anne Morrison and Leeanne Trenning. The continued engagement of our Secretariat has assisted the administration of the Association and the Committee meetings, management of events and publication of the Association's Facebook page and website. I would like to take this opportunity to recognise Kate & Martin along with their staff for the professional services conducted on our behalf by Cre8it Events, without them we would not achieve as much as we do. My deepest and sincere thanks to both Kate and Martin and their staff.

Our Membership has continued to face some pressure with a considerable number of members not renewing and a trend of some members only joining on the year when they attend the Conference. Our Membership numbers are slightly up for the year 2018/19. Carolyn Bourke's Treasurer Report will look at membership numbers in more detail however these are the figures as at end 2018/2019 Financial Year and as at 14 October 2019:

The Association is here for the benefit of its' members. Your active participation by providing feedback, promoting the Association and contributing to the Association is what makes this an Association that nurses and midwives want to be part of and get value out of their membership. I encourage you to continue to be active participants and let the executive committee know your thoughts and ideas.

On the subject of member benefits, I am pleased to advise that AQNML continues two member benefits that were introduced in 2017. AQNML's Bronze Affiliation with ACN provides members with a discounted Affiliate Member rate to ACN and a 5% discount off all CPD Courses.

This year the Executive Committee conducted a Planning Day in late 2018 to formally plan for this year's Conference, review budgets, membership and opportunities. At the planning day it was decided to divide the work into seven Special Interest Groups. Members were also invited to nominate to be part of a Special Interest Group. The work of the Special Interest Groups is planned to progress over at least two years and in many instances, will be ongoing.

The groups included:

Award Submissions

This group was led by Carrie Bourke and Andrea Nagle, members Alison Cilento, Jenny Goodwin and Katie Robinson also participated. The group have revised and refined the criteria and adjudication processes for both the Outstanding leader and the re - named The Colleen Rasmussen Emerging Nursing/Midwifery Leader Award.

Membership

Purpose of the working group – Increase the membership of the Association and to identify and enhance the benefits to nursing and midwifery leadership in Queensland, led by Pauline Calleja and Mel Daniels with support from members Jane Davies and Michele Burge. On the subject of member benefits, I am pleased to advise that AQNML continues two member benefits that were introduced in 2017. AQNML's Bronze Affiliation with ACN provides members with a discounted Affiliate Member rate to ACN and a 5% discount off all CPD Courses. There have been seven AQNML in action events. The team are really keen to encourage more of these in the next 12 months and particularly in line with the Nursing Now campaign.

Revenue Generation

Purpose of the working group is to review sponsorship and partner development opportunities. This working group consisted of Nicki Dennis and Anne Morrison. Currently the Conference is what makes our budget balance. We are not in the business of making money however, the Association has running costs and to continue, we need to remain financially secure to be able to increase the benefits to members and keep costs affordable. This year we have commenced charging for advertising, the team have more initiatives for consideration over the next 12 months.

Strategic and Operational Planning

The working group consisted of Anne Morrison, Wendy Fennah and Leeanne Trenning.

The purpose of the working group is to develop the strategic direction for the Association and how this will be operationalised. Our strategic priorities for 2019 – 2023 are:

- 1. To provide value for members
- 2. To be recognised as a key stakeholder for nursing and midwifery leadership
- 3. To be a key resource for development of nursing and midwifery leadership
- 4. To foster, grow and develop future leaders
- 5. To maintain relevance and opportunities for existing nursing and midwifery leaders

Mentorship Framework and Toolkit

Purpose of the working group is to review, make contemporary the Mentorship Framework and Toolkit and how this is implemented. The working group consisted of Anita Bolton and Lisa Mine. The group in reviewing the literature and other mentoring resources available have recognised that there are available resources that have recently been developed, specifically within Queensland Health. The team have recommended that to avoid duplication of effort we should seek to request the Queensland Health version be shared. A formal request has been sent to the Office of the Chief Nursing and Midwifery Officer to request the Queensland Health version of the Mentoring Framework be made available at no cost to members of the AQNML.

Communication Platforms and Social Media

Purpose of the working group is to increase the social media presence of the Association with regular and relevant contributions. Doug Kynaston and Mel Daniels have taken the lead. If you are actively on social media, you will notice, there has been a significant increase in social media activity, particularly Facebook posts over the past 12 months. Feedback has indicated that this has been a great way to keep members up to date with activities and further build on the profile of the Association.

Conference

Purpose of the working group was to organise the 2019 AQNML Conference program. Doug Kynaston, Jennifer Craig,

Mel Daniels and I have worked with Martin and Kate to bring together this year's Conference. We sincerely hope you are enjoying it and getting excellent value for your investment. We always attempt to vary the speakers, covering a wide range of topics to appeal to many. We are all very well aware of the influence culture has within an organisation and the challenge to promote and maintain positive culture hence the theme for this year's Conference.

AQNML continues to have a seat at the table of the Queensland Clinical Senate (QCS). The Queensland Clinical Senate represents clinicians and consumers from across the health system and provides strategic advice and leadership on system-wide issues affecting the quality, affordability and efficient delivery of patient care within Queensland. Over the last 12 months, the QCS has debated and produced recommendations on 'Maximising benefits of care', 'Health and wellbeing of the workforce" and "the digital state", all of these recommendations are available through the Queensland Clinical Excellence website. The QCS has also launched a podcast series, that interviews with clinicians from around the state regarding initiatives and programs to improve care for Queenslanders. Enormous thanks to Nicola Young for being our representative at the Senate.

The Committee continually reviews the financial position of the Association and we continue to face financial pressure. The Association will need to find new ways of maintaining membership growth and diversity to remain competitive. Our Nursing and Midwifery workforce remains under pressure to continue a focus on our professional practice and the need to have a strong voice in all health-related fields.

The financial position of the Association is detailed in the Auditor's report and Annual Financial Statement and within the Treasurer's report.

The Mentoring Framework has been utilised well this past year, with 155 downloads since July 2018-June 2019. Those who have download the Mentoring Framework have been added to the Association's database and will be keep updated with AQNML information.

AQNML Sponsored / Supported Events 2018-2019:

7. Financial Statements

Treasurer / Secretary Carolyn Bourke tabled the following Report.

It is with great pleasure that I present my second Treasurer's Report for the Association.

For 2018/2019 the Association has seen a small increase in membership numbers. As at 30 June 2019, total number of financial members equalled 170 (4 more than membership for financial year 2017/2018, which was 166).

2018/2019 Membership includes:

- 27 New Member Special 2018/19
- 16 New Member Special 2019/20
- 82 Full Member renewals
- 28 New Full members
- 5 Associate Member New Special 2018/19
- 2 Associate Member New Special 2019/20
- **3** New Associate Members
- 6 Associate Member renewals
- 1 Associate Member Interstate New Special 2018/19

The membership fees resulted in \$18,131.60 fees paid.

We continue to attract new members; however, we are noticing a trend that some members are not renewing their membership. One reason for this is many of our members are either retiring or on their way to retirement and some only joining for the year that they attend the Annual Conference.

You have a copy of the Financial Statement. These are our current assets as at 30 June 2019:

Cash at bank Operating Account: \$19,666.77

NAB Investment Account \$26,426.72

Conference Account \$25,137.57

Total Cash assets: \$71,231.06

Including total current liabilities, the net assets are: \$69,373.71

Compared to 2018 our net assets were \$111,940.61

This year there is a loss on paper for AQNML of (\$42,147.00)

This can be attributed to the following:

EXPENSES:

This report is heavily influenced by when Conference income and expenses are invoiced and received. You will note that there is some variance between 2018 and 2019 expenses. The figures reported can include Conference income and expenses that span the 2018 and 2019 Conference years. The Secretariat Fees for 2018/19 included 3 months which were not invoiced until July 2018 which were from 2017/18 year. Conference/Seminar costs were also significantly higher for 2018/19 which reflects when invoices were received and paid for the Conferences and includes 2018 & 2019 Conference Expenses.

While the Financial Year shows a significant loss, this is a paper loss only and is heavily affected by income for the Conference being collected later due to our Conference date being later in the year. AQNML continues to face the challenge of raising revenue with continued pressure on the membership base and AONML 2019 AGM Minutes 5

increasing expenses. The economic outlook for the 2019/2020 year remains conservative, and ongoing strong fiscal controls need to continue to ensure AQNML's ongoing financial viability.

INCOME:

Whilst 2019 income is significantly lower than 2018, this reflects when income is invoiced, primarily for the Conference and when it is paid.

There has been a general trend over a number of financial years that have being challenging for the Association, showing losses, it seems that this trend might be changing, as represented when reviewing the Profit / Loss over the 2017/18 & 2018/19 financial years, there was a profit of \$11,984.86. It will be important to keep reviewing profitability over the longer term and actioning the recommendations below from the Auditor. This may assist with a more accurate representation of the Associations activities each year.

AUDITOR RECOMMENDATIONS:

The Auditor has noted in the 'Management Letter for Audit Period ending 30 June 2019)

We would like to bring to your attention the following matters for the committee's consideration:

Item - Due to the nature of the association's operations and the date upon which the Annual Conference occurs each year; it could be beneficial for the Financial Reporting requirements to members if the association were to 'redefine' its financial year to the calendar year. This can be done via the Office of Fair Trading where you are able to choose either the financial year or the calendar year to report on an association's operations. If the association were to adopt the calendar year as its reporting period, it could provide a more accurate representation of the association's activities each year because the income and expenses for the conference would fall within the same financial year.

If this is not a solution you would consider, the other would be to adopt an accruals basis for you accounting records which would also work to pull the income and expenses into the same financial period and create proper cut-off and matching of Income and Expenses in compliance with Australian Accounting Standards and Principles.

With the future in mind, the AQNML Committee should consider reviewing all expenses and identify where savings can be made. This may include reviewing conference activities, for example, conference registration fees. This should be decided in conjunction with expected future income generated from membership.

Auditors, Simpson & Winslow's report verifies the AQNML financial records are in good standing and have provided the reports for our AGM.

I am happy to report that with our financial processes continue to be compliant with all Accounting Standards and are in a sound position for the Association to consider the utilisation of funds towards future development in priority areas as determined by our next Executive.

AQNML 2020 PRESIDENT'S REPORT



It is my privilege to present the President's report of the Association of Queensland Nursing & Midwifery Leaders (AQNML) for 2020, this will be my last report as President of the Association as I step down from this role following my 2 year term.

In opening, I would like to thank the members of the Executive Committee for their assistance, work and support over the past year. They are: Vice President Melinda Daniels, Secretary/Treasurer Lisa Milne and Committee Members – Anita Bolton, Michele Burge, Carolyn Bourke, Pauline Calleja, Nicki Dennis, Karyn Ehren, Debbie O'Brien, Tracey Pattie & Jenny Ralaca (resigned mid-term).

2020 is the international year of the Nurse and Midwife, this coincides with the 70th anniversary of the Association. We had planned some very exciting celebrations to raise the profile of the Nurse and Midwife, and to highlight the contributions of the professions to all aspects of health care, community, educational preparation, acute and primary care and population health to name a few. Of course, this did not pan out as we had planned, as with many other celebrations, including International year of the Nurse and Midwife celebrations. The professions, however, have most certainly come to the fore and this year. There has been global recognition of the pivotal role nurses and midwives have played and continue to do so in detection, prevention and response to the global pandemic COVID-19. This recognition is across front line, management and leadership roles. I don't think there is a single person who does not see the value nurses and midwives bring to the community. So, although many celebrations have been put on hold or cancelled, I think we can rest assured the community are well aware of our role and our contribution.

The Association began in 1950, as the Matrons Association and changed name in 1975 to the Nursing Superintendents Association, the association again changed in 1990 to the Directors of Nursing Association, DONA. In 2003 the Association changed its name to the Association of Queensland Nurse Leaders (Incorporated) AQNL, in 2017 the Association again changed its name to the Association of Queensland Nursing & Midwifery Leaders (AQNML). Each of the change in name has been brought about by the changes we have seen in the response to changes in recognition and development of the profession. We have expanded over the past 70 years to include emerging and aspiring leaders and are now an Association with 124 full members and 9 Associate members. The membership numbers are significantly lower than at June 2019, in part we believe this is due to the inability to hold a conference, many people join either at the conference or as they register. There are however many other benefits to membership of the Association, the ability to participate in AQNML in Action events, networking with peers, having a voice as a leader on matters that affect Nursing and Midwifery and I am pleased to advise that AQNML continues two member benefits that were introduced in 2017. AQNML's Bronze Affiliation with ACN provides members with a discounted Affiliate Member rate to ACN and a 5% discount off all CPD Courses.

The Treasurers Report will look at membership numbers in more detail however these are the figures as at end 2019/2020 Financial Year and as at 15 October 2020:

Members are encouraged to seek out any member of the executive committee and discuss any ideas they have for extension of member benefits and progress of the Association; it is your Association and as such your participation is actively sought and highly valued.

AQNML continues to have a seat at the table of the Queensland Clinical Senate (QCS). The Queensland Clinical Senate represents clinicians and consumers from across the health system and provides strategic advice and

leadership on system-wide issues affecting the quality, affordability and efficient delivery of patient care within Queensland. Nicola Young remains as our representative at the Senate, many thanks Nicola.

This year has been a difficult year for all in many ways. As an Association we need to constantly review our financial position. For the Association, we have needed to adjust the way we operate. We have been agile in our response to the restrictions brought about through the COVID -19 requirements. We have moved to delivering AQNML in Action as online events, these have been successful with good engagement and much positive feedback. To date we have provided 6 events, the events were recorded and are available to members to view online through the Associations website. Given we have not been able to hold a conference this has had significant impact on the organisations finances, our Treasurer will provide a detailed overview in her report, however I wish to make comment that it has required a committee response also. The executive has been asked to consider how they can take on a greater load, by undertaking activities that would normally sit with our secretariat. There are a number of committee members who have risen to this challenge by committing to undertake specific activities, Deb O'Brien has taken on the management of the AQNML Social media presence and Anita Bolton and Tracie Pattie has volunteered to minute and record our meetings, this has reduced the impact on the Secretariat services.

The financial position of the Association is detailed in the Auditor's report and Annual Financial Statement and within the Treasurer's report.

I want to express my gratitude to my fellow Executive Committee members, for their support and their contribution. In deciding to become a committee member I acknowledge the energy and effort required also the value of being on the AQNML Executive. There is a Roles and Responsibilities Framework which outlines the expectations of being a member of the Executive Committee. It was included with the Nomination Form sent to all members with the Notice of the AGM. We really need you to understand the commitment required of these roles, and in taking on a position being prepared to complete these commitments.

It has been a privilege to serve as the AQNML President for the past 2 years. AQNML 2020 TREASURER'S REPORT

It is with great pleasure that I present my first Treasurer's Report for the Association.

For 2019/2020 the Association has seen an increase in membership numbers. As at 30 June 2020, total number of financial members equalled 192 (22 more than membership for financial year 2018/2019, which was 170).

2019/2020 Membership includes:

- 38 New Member Special 2019/20
- 18 New Member Special 2020/21
- 92 Full Member renewals
- 38 New Full members
- 2 Associate Member New Special 2019/20
- 0 Associate Member New Special 2020/21
- 5 New Associate Members
- **4** Associate Member renewals
- 0 Associate Member Interstate New Special 2018/19

The membership fees resulted in \$23,872.47 fees paid.

We continue to attract new members; however, we are noticing a trend that some members are not renewing their membership. One reason for this is many of our members are either retiring or on their way to retirement and some only joining for the year that they attend the Annual Conference.

You have a copy of the Financial Statement. These are our current assets as at 30 June 2020:

This year there is a loss on paper for AQNML of (\$12,268.14)

This can be attributed to the following:

EXPENSES:

This report is heavily influenced by when Conference income and expenses are invoiced and received. You will note that there is some variance between 2019 and 2020 expenses. The figures reported can include Conference income and expenses that span the 2019 and 2020 Conference years.

While the Financial Year shows a significant loss, this is a paper loss only and is heavily affected by income for the Conference being collected later due to our Conference date being later in the year and the postponement of the 2020 Conference due to Covid-19. AQNML continues to face the challenge of raising revenue with continued pressure on the membership base and increasing expenses. The economic outlook for the 2020/2021 year has been identified by the

AQNML Committee as a concern with the loss of Conference Income and uncertainty affecting membership numbers. The committee has taken steps to reduce expenditure in the 2020/2021 year by reducing Secretariat hours and managing other expenses to ensure AQNML's ongoing financial viability.

INCOME:

Whilst 2020 income is higher than 2019, this reflects when income is invoiced, primarily for the Conference and when it is paid.

It is important for the review of performance over a 3-5 year period due to the impact of Conference Income and Expenses being spread over financial years. There has been a general trend over a number of financial years that have being challenging for the Association, showing losses but over the longer term it reveals a clearer picture.

Profit / Loss 2016/17 (\$2,434.60) 2017/18 \$54,551.76 2018/19 (\$42,566.90) 2019/20 (\$12,268.14)

The 2019/2020 result was impacted by Covid-19 resulting in the Conference being postponed until 2021 while some deposits were paid and are being held by the Conference Venue and Conference Dinner venue.

The ASSOCIATION OF QUEENSLAND NURSING & MIDWIFERY LEADERS INC. holds a Conference each year at the end of the calendar year. It is significant to note when reading the Financial statements that a total of Income received in advance of \$56,201.88 is reported as a part of Conference Income in the comparative financial year yet most of the expenses for that Conference were incurred in the 2020 Financial Year. The Net Profit for the 2018 Conference in total over two financial years was \$4,011.00.

With the future in mind, the AQNML Committee should consider reviewing all expenses and identify where savings can be made. This may include reviewing conference activities, for example, conference registration fees. This should be decided in conjunction with expected future income generated from membership.

Auditors, Simpson & Winslow's report verifies the AQNML financial records are in good standing and have provided the reports for our AGM.

I am happy to report that with our financial processes continue to be compliant with all Accounting Standards and are in a sound position for the Association to consider the utilisation of funds towards future development in priority areas as determined by our next Executive.
